1. Roll Call, Introductions and Minutes

- Jeanne moved to approve minutes from March 29th. All approved.
- 1. President's Report: Jerry Simone
 - No donations to approve.

 current policy sent out by Jerry. The policy has a list of all the insured boats. Please look at the end of the
 document, make sure the listed boats are still in use and that the document includes accurate information

 - Can the names of the boats be added to the policy to make it easier to determine which boat is which. Is it necessary to still insure the Susan Rebaults, 4 donated by CPH?
 - Once the pink slip has been transferred to HBRA the trailer should be added to the policy. Currently dealing with Traverse Flemming from CPH, but have not heard back from him.

3. Coaching Status Report

- Coaching Report provided by Head Coach Chris Dadd
 - Once Olivia leaves, new coach will be needed for the Masters. Chris and Shenae will coach the juniors.
 Seems like there are several new enthusiastic juniors with good age distribution.
 - Many new scullers getting certified.
 - Fall dates for juniors 8/18 is the last day of the summer session. 9/5 or 9/11 seem like good options. Target 9/5. Continue recruiting for more juniors.
 - Jerry will email a contract to Shenae Bishop. She has keys and the boat house combination. Mary Ann will get her on US rowing. Will use Jerry's credit card to put her on US rowing.
 - Lisa Wiess might be willing to coach the masters will ask Olivia to find out.

4. Safety Committee: Laura Miller

• Mary Ann asked if it is necessary to generate a new waiver for the Masters. Might need to include health conditions. Should know about diabetes, heart conditions and seizures. Not necessary to know everyone's medical history, however, it might be good to have the language that the waiver includes. Would be good to have emergency contacts and a statement saying is there any reason your doctor would not recommend vigorous exercise.

6. Equipment update provided by Head Coach - Chris Dadd

- Klamath Launch is now usable, takes on water but usually only a couple of cups.

- Roof update should start a Capital campaign to fundraise. Jerry recommends A and I and Alves. Get an estimate first so that total cost is known. A bigger company might be able to give a discount/donation or even at cost. Chris will get bids from all three companies: A and I, Alves and McMurray and sons.
